I. CALL TO ORDER E. DILKES

- a. The Meeting was called to order at 11:04 A.M.
- b. Motion to accept minutes from May 22, 2018
  - i. Jeff Zarrinnam moved to accept the minutes as published
  - ii. Bob Winters seconded
  - iii. Motion Passed MSP

#### II. EXECUTIVE DIRECTOR'S REPORT

R. SCHWARTZ

- a. Robert Schwartz briefly reported on the following items
  - i. SWAPMEET
    - 1. Robert informed the Committee about a phone called from the District auditor requesting a copy of the agreement between the Foundation and the Swap Meet
      - a) Robert mentioned that the agreement with the District was never signed by President Renee Martinez and the Jim Watson even thought it was approved by the Board of Trustees back in August 2017. Now, President Gallagher will have to review the contract and sign it
    - 2. The Swap Meet revenue was up \$13,351.11 from last year
    - 3. The Swap Meet commission for May 2018 was \$56,016.64 for both Saturday and Sunday
    - 4. Year-to-date total is \$288,081.40

#### ii. ALUMNI

- 1. Robert mentioned that Carole Wenger has contacted some alumni and she's meeting with some of them
  - a) Steve Lebowitz was here for the sculpture dedication and asked about the veterans housing. President Gallagher supports it 100%. Steve is still onboard with this project and so is his friend
  - b) John Branca is considering fiving \$100K to create the John Branca Institute for Entertainment Business and Law. Carole also is talking with John's colleague Johnny Lockwood about this donation
  - c) Mark Hamill agreed to do shout out or radio spot for LACC
  - d) Sandy Hyun is creating another scholarship in the amount of \$25k
  - e) Andy Khawaja is LACC alum and he was first mentioned by Mayor Eric Garcetti. Andy owns Allied Wallet and Robert will contact him
  - f) Graduway currently has about 130k records to start working

#### iii. GRANTS

- 1. This month the LACCF was awarded \$15,000 from the Kirchgessner Foundation to support the Office of Special Services, with tutoring and equipment
- 2. The Foundation along with grant consultant, Amy Hanf, completed the proposal to the Catalyst Fund, which we were invited to submit. Funding is designated to programs that demonstrate a range of creative approaches to serve undocumented students and their families in sustainable ways

- a) LACC will use this funding to run a comprehensive Dream Center.
- 3. One additional proposal was submitted to the Freeberg Foundation to fund the capital improvements the Veterans Resource Center
- 4. There were five additional Letters of Intent that were submitted, four for general operating funds, and one for the nursing department

#### iv. CORPORATE & FOUNDATION RELATIONS

- 1. Martha Pelayo submitted her report and Robert briefly discussed it with the Committee members
  - a) Thanks to Steve Nissen, NBC VP who is a Parsons Foundation Board member, a meeting with Parsons Director was scheduled for June 22 between LACCF and GSP coordinator to discuss GSP funding
  - b) Deloitte Foundation after a conversation with Kristen Chernick of the Foundation, she introduced Martha with the local talent acquisition representative, Melinda Johnson. Martha and Melinda had a conversation and she mentioned that Deloitte did not fund community colleges and their focus is on students that are about to graduate with their Bachelor's degree which is the minimum degree needed for their jobs
  - David Ambroz coordinated a tour for Kyle Bishop, ABC Studios Director of Production Services. Kyle
    oversees the Asset Management and agreed to assist Theatre and Cinema/TV department as liquidation of
    costumes and props occur

# v. PRESIDENT'S SCHOLARS

- 1. Robert mentioned that this year we are having issues recruiting President's Scholars. We only have about 11 students since UC Merced is offering full rides and a lot of those student decided to go to UC Merced instead of LACC
  - a) Robert's friend offered to buy laptops for LACC top students

## III. COLLEGE ADMINISTRATIVE REPORT

#### M. GALLAGHER

- a. President Gallagher briefly reported on this year's enrollment which was about 19,000 for both credit and non-credit.
- b. She also mentioned that the budget is looking good and most likely they will end the year in black
- c. President Gallagher talked about their two strategies they have for enrollment and the online AA degree
- d. She also reported on the campus construction activities, grounds & custodial and customer services
